AB Manager Features

AB Manager's key features include:

System Design

 - Secure, web-accessible database platform.
- Easy to access from any web-connected desktop, laptop, or tablet.
- Includes cloud storage for system-generated files. Export capability for backup of critical data tables.
- Initial data migration support from existing database files (labs info, key personnel, etc.).



Excellent customer support for initial setup and ongoing maintenance.

Analytical Parameters

- Allows each AB to specify allowable parameter combinations (matrix, program, method, and analyte).
- Uses nationally recognized (TNI) method and analyte codes. Also allows for AB-specific analyte or method codes, if needed.

Laboratory Demographics, Key Personnel, and Fields of Accreditation

- Capable of managing an unlimited number of laboratories including lab demographics, location(s), key personnel, etc.
- Tracks lab contacts, the primary contact, and the start and end dates of any key positions that each contact has had.
- For each laboratory, tracks requested and approved parameters (matrix, program, method, and analyte).
- Includes a detailed PT analysis for each requested parameter including TNI overall score and method-specific PT for EPA drinking water.
- Recurring and non-recurring assessments can be assigned to each laboratory. Each assessment type includes customized milestones for effective task scheduling.
- Laboratory certificates, including approved fields of accreditation, are automatically generated.
- Automated invoicing is based on AB-specific fee schedules.

Electronic Laboratory Applications

Includes an automated application process to simplify and improve the initial and renewal application process.

AB Manager generates an application spreadsheet that is pre-populated with laboratory demographics, key personnel, and requested fields of accreditation.

Laboratories update the application spreadsheet and return the file to the AB.

The completed application file is uploaded directly to a staging area. Changes are highlighted for easy review, approval, and importing.

Proficiency Test (PT) Evaluation

- Automated uploading of proficiency testing (PT) files from any PT provider.
- Preliminary screening of PT data uploads for validity and completeness.
- Various data views for semi-automated PT evaluation (TNI and method-specific).
- A detailed PT analysis is provided for each requested parameter including TNI technology score (Pass-3/3, Pass-2/3, etc.) and EPA's method-specific result.
- TNI PT evaluation includes analysis of timeframes between studies (e.g., closing date to closing date must be less than 7 months).
- Failed PT results are grouped by method and added to a PT Action table, allowing the AB to track receipt of laboratory corrective actions.

Assessments, Milestones, Checklists, and Reports

- Define assessment types (e.g., annual renewals or biennial on sites) with customizable milestones for each.
- Automatically creates an overall priority/to-do list for each milestone type (e.g., on-site scheduled or on-site completed).
- Specific features for assessments that include an on-site audit.
- Allows users to develop an unlimited number of customized process or method checklists. Checklists design can include sections, labels, questions, signature, etc.
- Multiple checklists can be added to an assessment package.
- Audit findings and recommendations can be easily populated from checklist observations or added manually.
- A customized audit report can be generated quickly and easily after finalizing the findings and recommendations.
- Once all steps in an assessment have been completed, a new assessment is generated according to a pre-determined schedule with a fresh set of milestone dates.


Certificates


